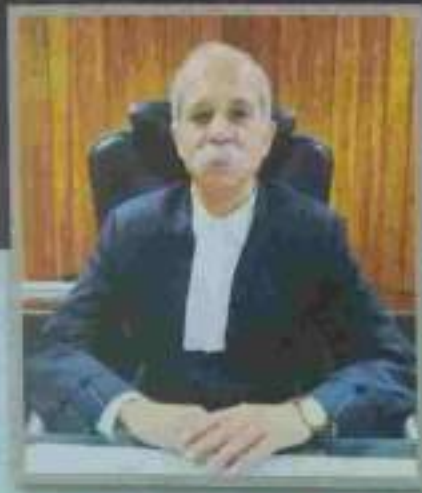

*N*ational Lok Adalat :

On 14.12.2019, National Lok Adalat was conducted by HCLSC and all the DLSAs & SDLSCs as per guidelines of NALSA wherein 5,125 numbers of cases were taken up for disposal in 50 Nos. of Courts and out of that 785 nos. of cases were disposed of on settlement and a sum of Rs. 1, 50,92,910/- was realized as settlement amount.

*T*raditional Lok Adalat :

- i. On 08.12.2019, under SDLSC, Bishalgarh, a Traditional Lok Adalat was conducted where, 500 numbers of M.V Act Cases & T.P Act cases were taken up for disposal and out of them 236 numbers of cases were disposed of and the total settlement amount was Rs. 15,900/-.
- ii. On 22.12.2019, under DLSA, West Tripura, a Traditional Lok Adalat was conducted where 772 numbers of M.V Act Cases & T.P Act, Excise Act cases were taken up for disposal out of them 2345 numbers of cases were disposed of and the total settlement amount was Rs. 27,550/-.

Best PLV of Northeast Region

Shri Ranjit Paul, Para Legal Volunteer of West District Legal Services Authority has been awarded as the Best PLV of Northeast Region during a programme held at the newly constructed auditorium of Supreme Court on 9th November 2019 in New Delhi.
