CIRCULAR

The Education Department (School) is committed to ensure the accessibility to quality education for all the Children With Special Needs (CWSN) in an inclusive environment

In this regard, the following Sections of the RTE Act, 2009 and RPWD Act, 2016 have been quoted for easy reference and strict adherence:

1. Section 3(1) of Chapter II of RTE Act, 2009: "Every child of the age of six to fourteen years shall have a right to free and compulsory education in a neighbourhood school till completion of elementary education".

And in the same chapter, clause 2 of Section 3 states that if the child is suffering from disability that child shalf have the rights to free and compulsory education in accordance with the provisions of Chapter V of PWD Act, 1996.

- 2. Section 8 Sub Clause II states that the appropriate government shall ensure compulsory admission, attendance and completion of elementary education by every child of the age six to fourteen years.
 - 3. Section 15 of the said Act, regarding admission it is mentioned:

"A child should be admitted in school at the commencement of the academic year or within such extended period as may be prescribed:

Provided that no child shall be denied admission if such admission is sought subsequent to the extended period?

- 4. RPWD Act, 2016 in Section 16 states that "the appropriate Government and the local authorities shall endeavor that all educational institutions funded or recognized by them provide inclusive education to the children with disabilities and towards that end shall—
- (i) admit them without discrimination and provide education and opportunities for sports and recreation activities equally with others;"

In this connection, it is requested to all the concerned Officers/Officials of the Department to adhere to the above mentioned Sections of RTE Act, 2009 and RPWD Act, 2016 and to take admission of any CWSN at any point of time of the Academic Year, failing which strict disciplinary actions will be taken against the concerned Officers/officials.

The District Project Coordinators (DEOs) are requested to take necessary measures to disseminate the circular to all concerned HMs/AHMs/T/Cs across the State.

A meeting was held with State Commissioner for persons with Disability on 18/08/2021 and in compliance the following is issued:

The Right of Children to Free and Compulsory Education (RTE) Act, 2009 enshrines the entitlement to free and compulsory elementary education, access to school and barrier free access for all children including children with disability. Section 3(2) of the RTE Act lays emphasis on the elementary education of all children with disabilities.

And whereas, Tripura Board of Secondary Education, in their Regulation, 2020 declared that Divyang Candidates will get 1 (one) hour for written examination for every 3 (three) hours of duration w.e.f Madhyamik Exam. 2020 and H.S(+2 stage) Exam. 2020.

And whereas, Mostry of Social Justice and Empowerment, Government of Incia in their office memorandum dated 29/08/2018 montioned that all the candidates with benchmark disability may be allowed compensatory time of one hour for Examination of three hours duration.

And whereas, at elementary & secondary level under School Education Department, Government of Tripura there exists no provision of compensatory time for students with benchmark disability.

Now, therefore, Education (School) Department, Government of Tripura hereby notifies that

- i) Students of elementary and secondary level with benchmark disability will get compensatory time @ 20 minutes per hour for three (3) hours duration examination.
- ii) Any individual desires to avail the benefit will have to produce disability certificate from the competent authority.

This notification shall come into effect from the date of publication in the official Gazette.

1. INTRODUCTION:

Education plays a pivotal role in socio-sconomic empowerment of Persons with Disabilities. It has been felt necessary by the State to encourage meritorious students with benchmark disabilities by providing financial aid to them in order to achieve their career goals. It is also envisaged to minimize the incidence of dropout of meritorious students with benchmark disabilities by providing them career support. Persons with benchmark disabilities often face several barriers while pursuing their career in the form of physical, financial, psychological and mental hardship which often dissuade them from achieving their goals in life.

The award aims to support the meritorious students with benchmark disabilities to study further in order to prepare themselves to achieve their goals so that they can earn their livelihood and find a dignified place for themselves in the society.

2. AWARD COMPONENTS:

- 2.1. One time Award amounting to ₹24,000/- only to the 5 nos, students with benchmark disabilities who have topped among the students with benchmark disabilities in Matriculation Exam conducted in any educational institute (Govt., Govt.-aided, private) recognized by Education Department, Govt. of Tripura and are pursuing Class XI.
- 2.2. One time Award amounting to ₹54,000/- only to top 5 ncs, students with benchmark disabilities (2 ncs, award for Science subject, 2 ncs, award for Arts subject & 1 nc. award for Commerce subject) who have topped among the students with benchmark disabilities in Higher Secondary Exam conducted in any educational institute (Govt., Govt.-aided, private) recognized by Education Department, Govt. of Tripura and are pursuing Higher Education.

3. GENERAL CONDITIONS OF ELIGIBILITY:

The general conditions of eligibility of all the components of the scheme are given below:

- 3.1. The Award is open to the students with benchmark disabilities who hold the 'Permanent Residents of Tripura Certificate'.
- 3.2. The Award is applicable to students with benchmark disabilities and having a valid certificate of disability as prescribed under rules issued by the competent authority. (Benchmark Disability is as defined in "The Rights of Persons with Disabilities Act, 2016").
- 3.3. The student with benchmark disability should have cleared the Matriculation Exam Higher Secondary Exam conducted in any educational institute (Govt., Govt.-aided, private) recognized by Education Department, Govt. of Tripura.

- 3.5. As the award amount is to promote only mentionics situaents with benchmark disabilities, there shall be no annual parental guardian's income bar ('Guardian' shall be a person declared by Competent Authority responsible for the student with disabilities')
- 3.6. Employed students with benchmark disabilities shall also be eligible under the scheme to avail award.
- 3.7. The award shall not be a bar to any student from getting other benefits or schemes which they may be entitled to receive.

4. IMPLEMENTATION:

- 4.1. The Education Department shall be responsible for selecting the top 5(five) nos. students with benchmark disabilities:
 - A. Who have topped among the students with benchmark disabilities in Matriculation & Higher Secondary Exam conducted in any educational institute (Govt., Govt.-aided, private) recognized by Education Department, Govt. of Tripura,

AND

- B. Who are confirmed to have taken admission for pursuing their Higher Secondary or Higher Education.
- 4.2. The Education Department shall then send the details as per following format to the Social Weifare & Social Education Department, every year, within 2 months from the date of declaration of results for Matriculation & Higher Secondary Exam:

5. FURNISHING OF FALSE INFORMATION:

If any candidate has furnished any false information/ document and is established as false, he / she will be debarred from the award and if he / she has availed it an action will be initiated for recovery of the amount with 15% interest thereon. Such candidate will also be black //stad for future and appropriate legal action can be taken against the candidate.

6. JURISDICTION OF THE SCHEME:

The jurisdiction of the Schemes is to provide prescribed financial support to the selected candidates for pursuing education. The Scheme does not cover employment aspects of the awardees and also does not provide for any kind of assistance to the awardees in seeking employment after his/her having availed of the award.

7. CHANGING THE PROVISIONS OF THE SCHEME:

The Department of Social Welfare & Social Education, Govt. of Tripura may, at its discretion, make necessary changes in the provisions of this scheme, as and when felt necessary, with the approval of Principal Secretary/Secretary/Special Secretary, Social Welfare & Social Education Department, Govt. of Tribura in consultation with the Finance Department & Education Department.

MEMORANDUM

Subject: Entitlement of Child Care Allowance and Disability Allowance Clarification thereof.

Several proposals have been received from various Departments seeking clarification on simultaneous entitlement of Child Care Allowance and Disability Allowance by State Government employees and workers. The matter has been examined in Finance Department. As per guidelines, Disability Allowance shall be applicable to physically handicapped and visually handicapped State Government employees @ Rs. 1000/- per month while disabled Fixed Pay, DRW and Contingent Workers etc., shall get the same @ Rs.700/- per month. Similarly, Child Care Allowance is allowed @ Rs.1000/- per month for physically handicapped and visually handicapped State Government employees and workers and also to employees having Disable child. Maximum ceiling has been kept at Rs. 2000/- per month for entitlement of both allowances together in admissible cases.

- Some Departments have sought clarification on entitlement of the aforesaid allowances in case of disabled employee with a normal child and vice-versa. After careful examination of the matter, the following points are clarified :-
 - Able-bodied State Government employees having disabled child shail get Child Care Allowance @ Rs. 1000/- per month.
 - Disabled State Government employee shall be allowed with Disability Allowance @ Rs.1000/- per month and Child Care Allowance @ Rs.1000/per month, irrespective of whether the child is disabled or not. In any case, both the allowances taken together shall not exceed Rs. 2000/- per month.
 - (iii) Disabled State Government employee without any children shall also get Rs.1000/- per month as Disability Allowance.
 - (iv) Able-bodied fixed pay, DRW, Contingent Workers etc. having disabled Child shall be allowed Child Care Allowance @ Rs. 1000/- per month.
 - Disabled fixed pay, DRW, Contingent Workers etc. shall be allowed with Disability Allowance @ Rs.700/- per month and Child Care Allowance @ Rs.1000/- per month, irrespective of whether the child is disabled or not. In any case, both the allowances taken together shall not exceed Rs. 1700/- per month.
 - (vi) Disabled fixed pay. DRV(, Contingent Workers etc. without any children shall also get Rs.700/- per month as Disability Allowance.
 - (vii) A Government employee or fixed pay, DRW. Contingent Workers etc. vato normal child will neither be allowed Disability Allowance nor with Child Care Allowance. Contd...P/2

- 3. It shall be the responsibility of the concerned DDO of the establishment to ascertain the entitlement of Disability Allowance and Child Care Allowance to the admissible set of employee(s) after proper verification of records etc., satisfyingly their entitlement.
- 4. In view of the above, all Heads of Department(s)/ Head of Office(s) is requested to take necessary action on the simultaneous entitlement of Child Care Allowance and Disability Allowance as clarified above.

Clarification has been sought from different Departments regarding the maximum age of a child of a disabled Government employees for allowing Child Care Allowance.

After careful examination of the matter in the Finance Department, it is hereby clarified that Child Care Allowance shall be admissible to that disabled Government employees till the child aftains the age of 18 (eighteen) years.

This is in continuation of earlier Clarifications issued vide this Department Memo No. F.7(2)-FIN(PC)/2017 dated 4th April, 2018.

Subject: Family pension for life to children suffering from disorder/disability of mind or are Physically crippled/disabled-Discontinuance of the condition of menifestation of the disability before retirement or death in harmess of the Government servats for grant of -

The undersigned is directed to state that according to the extent provision of rule 54(6) of the C.C.S(Pension) Rules—1972 as adopted read with this Deptt. Memo. of even number dated 1st September, 1989 family pension for life is payable to children suffering from disporder/disability of mind or who are physically crippled/disabled render rendering them unable to earn a living even after attaining the age of 25 years for sons and 30 years for daughters subject to fulfilment to a the pensionery benefit if the disability had menifested itself before the retirement/death in hamess of the Govt. sefvant vide Explanation(a) under Rule 54(6) of C.C.S.(Pension) Rules, 1972 as adopted.

- 2. After careful consideration of the matter the Governor, Triple is pleased to decide that the requirement of menifestation of the disability before his retirement/death in harness of a Govt. servent as precondition for grant of life time family pension as stipulated in the explanation(a) under Rule 54(6) of C.C.S.(Pension) Rules, 1972 as adopt may be dispensed with.
- The Governor is also pleased to decide that the eligible disabled childred who were not granted this benefit due to the absence necessary provisions in the hule/orders prior to the date of 18th Sept. 1974(i.e. the date of the effect of the U.C.S. (Pension) Rules, 1972 as adopted) will also now be eligible for the benefit of life time payment of family pension. This is subject to the condidtion that they are not already in receipt of any pension or are eligible therefor under any other rules of the State Govt. or the Central Govt. and a Bublic Sector undertaking/Autonomous Body/Local Fund under State Or Central Govtx.
- 4. It is clarified that the benefit referred to in para 2 and 3 above will be admissible only to the eligible disabled children, whethe berng before or after retirement from marriage that took place before retirement of government servant and that its grant shall continue to be governed by the other conditions stipulated in rule 54(6) of the C. (Pension) Rules, 1972 as adopted and the explanation thereunder.

- NOTIFICATION

Empowerment of Persons, facing physical and mental challenges by provision of required medical, financial and other assistance, is a major responsibility of the State First step of this process involves identification of the persons and issuing certificate regarding the nature and extent of disability. New guidelines for evaluation and certification of various disabilities have been laid down as per provisions under Section 56 of the Rights of Persons with Disabilities Act; 2016.

- 2. Subsequently, Ministry of Social Justice & Empowerment, Govt. of India has issued guidelines for evaluation, of various disabilities and procedure for certification vide Notification dated 4th January, 2018 (Copy enclosed as Annex-I).
- 3. Keeping in view the imperiance of the matter and the fact that the various rights of persons with disabilities is dealt by the Department of Education (Secial Welfare & Social Education), Health & Family Welfare, Labour, Employment and Education (School Education) as well as the District Administration, the Governor, Tripura is pleased to notify the modalities, role and responsibilities of various agencies as indicated below for compliance on issue of disability certificates for appropriate action by all concerned with immediate effect.
- 4.1 Annexure II of the notification mentioned in para 2 above specifies the eight different categories of specified disabilities. These are as follows:-
 - locometer disability including cerebral palsy, leprosy cured, dwarfism acid attack victims and muscular dystrophy;
 - II. bijnoness and low-vision,
 - III. deaf and hard of hearing and speech and language disability.



- IV. intellectual disability and specific learning disabilities,
- V. mental illness;
- VI. chronic neurological conditions;
- VII. haemophilia, thatassemia and sickle cell disease; and
- VIII. multiple disabilities.
- 4.2 As per provision of Section 57 of the Rights of Persons with Disabilities Act, 2016 the authorities along with their jurisdiction for the purpose of issue of disability certificate is given in the table below:-

Application for obtaining certificate of disability shall be made in Form IV of the Rights of Persons with Disabilities Rules, 2017. Disability Certificate shall be issued in the prescribed formats viz. Form V-VII of the Rights of Persons with Disabilities Rules, 2017. Intimation of rejection of application for certificate of disability, if applicable, shall be issued in Form-VIII of the Rules (Copy of the Rules are at Annex-II). The procedure and modelities for issue of Certificate of Disability shall be as per Rules 17 -20 of the Rights of Persons with Disabilities Rules. 2017. The Certificate of Disability shall be to

the maximum extent feasible granted on an online platform (Unique Disability ID Portal of Government of India.)

- 4.4 The District level boards shall meet on at least once on the specified week days, as follows:-
 - (i) DDRC West, West District Wednesday
 - (ii) DDRC South, Gomati District Monday
 - (iii) DDRC Dhalai, Dhalai District —Thursday
 - (iv) DDRC North, Unakoti District-Thursday

This arrangement will help in sending doctors from Agartala to the other Districts on the specified dates as may be required. The District Board shall also meet often as deemed necessary.

- 4.5 In addition to the Board Meeting on the specified day of the week, special camps may be held at other locations for covering interior areas in particular, as required from time to time.
- 4.6 The AGMC appellate Board may meet at least once in a month or more often, if deemed necessary and deal with grievance and appeals regarding issue of disability certificates, if any, on the decisions of the district level medical boards.
- 5 For issue of disability certificate to students studying in various schools, Director, School Education shall extend necessary support to the Health and Family Welfare Department in respect of the following:
 - i. Principal/Headmaster of the Educational Institutions shall be responsible for arranging the issue of the certificate to all students facing challenges
 - ii. The Principal/Headmaster shall request the Chief Medical Officers of the DDRCs for holding special camps for issue of disability certificate.
 - iii In case the Medical Eoard is of the view that the evaluation of disability of a particular student can be done only after carrying out certain tests with

the equipments available at the District level, required support may be extended for taking the student to the district level Hospital by the school authority.

- The disability certificate may be given to the Principal/ Headmaster who shall keep it in the personal file of the concerned student and hand over it along with the School Leaving Certificate, which is issued when the student leaves the school or as and when required:
- 6. Disability Certificate will be issued to the Person free of cost.

This issues in supersession of all previous notifications of the State Government in this regard and shall come into immediate effect.


