- **02)** Quotation should be supported with a copy of ITC, PTC, Factory License, Trade License and SSI Registration Certificate of the current validity;
- O3) Quotation should be furnished in proper Pad of the Firm duly signed by the Proprietor;
- O4) Hoarding will have to be supplied in good condition and to be printed as per direction of TSLSA as per specification mentioned in NIQ;
- 05) The content and design of hoarding is subject to approval of the TSLSA;
- O6) Tenderer/Supplier will be responsible for fitting and fixing of hoarding subject to places selected by TSLSA;

- O7) Tenderer/Supplier will be responsible for obtaining permission and deposit remittance of Rental charge/Fees to the AMC/local respective authority for installation of hoarding;
- 08) Necessary taxes would be deducted from the bill;
- O9) Any inferior or sub-standard quality of works will be rejected and no payment will be made from TSLSA;
- 10) Payment will be made subject to verification by the Legal Services Officials of the respective District / Sub-Division. Photograph of each hoarding should be submitted along with the bill in triplicate for payment;
- 11) The Tenderer will be responsible for the placement of Printing Flex (matter of TSLSA), if the same defaced/ damaged / broken prior to one year period from installation;
- 12) The Flex/Hoarding with structure would be personal property of TSLSA; and
- 13) Separate rate would be quoted for 02 different sizes as per specification by the Tenderer / Supplier.
