

APRIL - 2018

NATIONAL LOK ADALAT:

On 22.04.2018, Monthly National Lok Adalat was conducted as per guidelines of NALSA wherein 4130 numbers of cases were taken up for disposal in total 46 Nos. of Courts and out of that 701 nos. of cases were disposed of on settlement and a sum of Rs. 1,41,48,389.50/was realized as settlement amount.

SPECIAL LOK ADALAT:

- On 08.04.2018, under DLSA, West, a Special Lok Adalat was conducted where, 9000 numbers of M.V Act Cases & T.P Act cases were taken up for disposal, among them 4110 numbers of cases were disposed of and the total settlement amount was Rs. 2,88,400 /-.
- On 22.04.2018, under DLSA, Gomati, another Special Lok Adalat was conducted where, 403 numbers of M.V Act Cases & T.P Act cases were taken up for disposal, among them 156 numbers of cases were disposed of and the total settlement amount was Rs. 35,500/-.





Agartala, April 22: Along with other parts of the country. Tripura State Legal Service Authority (TSLSA) conducted National Lok Adalat today at 46 locations of the state to resolve different type of cases

Tripura State Legal Services Authority (TSLSA) through a press communique said that based on the directives of Nanonal Legal Service Authority, a total of 46 courts of Tripura including High Court has resolved the pending cases of motor vehicle act, NI act, matrimonial cases, BSNL bill recivil and covery cases, criminal compoundable cases, family disputes, bank's nonperforming asset case, disposal of Traffic Chillan cases etc.

TSLSA added that altogether 4,130 pending cases were taken up in courts for disposal. but only 701 cases were resolved on today and a total of Rs.1, 41, 48,189 Wwarded money was also collected thating disposal of cases

Earlier, the summons to all the parties of these cases were issued by the respective courts and TSLSA has requested all concerned persons to remain present on the scheduled date in their respective courts for disposal of pending cases. TSLSA solded that, maximum cases were not disposed in absence of parties related to the cases. Despite pass pressure. of presecution and defence parties, it is encouraging that the people are taking interest and more and more cases see being resolved day by day, said an official of TSLSA.
