Today the meeting of DLSA, North Tripura District is held in the chamber of the District & Sessions Judge, North Tripura District who happened to be the Chairman of the DLSA, North Tripura District with the following members:-

On scrutiny of their applications it is found that Smt. Moumita Bhattacharjee has submitted mark sheets of examinations obtaining the degree of Master of Social Work. She has also submitted completion of certificate of Internship wherein it is mentioned that she was placed in Child in Need Institute (CINI), West Bengal. She has also submitted certificate of her participation in Women Entrepreneurship Development and her participation in Life Skill Education Training and her participation in District Level Committee for Crimes Involving Women regarding hearing, spot visit, Group Discussion, Case work, Individual Discussion etc. for one year. She has also submitted certificate of participation in Two Days State Level Workshop on Promotion of Village Industries and certificate of her participation in three days National Seminar on Contemporary Education Crisis, Integrated Approaches to Higher Education and Research. She has also submitted a certificate regarding her works as Counselor in the Childline Project in the North Tripura District run by Sanghadip, Voluntary Organization.

It is also found that Smt. Sangita Nath has submitted mark sheets of examinations obtaining the degree of Bachelor in Hospital Management. She has also submitted copies of her Adhar Card, OBC certificate, PRTC, employment exchange card and Voter ID card. She has also submitted her certificate of completion of one year Diploma course in Computer Application. She has also submitted a certificate of her working experience as a receptionist in Mediscan Diagnostics, at 59 HGB Road, Paradise Chowmohuni, Agartala.

On perusal of the application of Sri Gopal Krishna Dutta it reveals that though he mentioned in his petition regarding his

various skills but he has not filed any documents in proof of that skills.






