2. The Sub-Divisional Legal Services Committee will pay such fee / remuneration to the Panel Lawyers without delay as soon as report of completion of the proceeding duly certified by the Judge of the concerned Court is received from the lawyer along with his bill.
3. Endorsement of cases to panel lawyer and withdrawal of cases from such lawyer shall be regulated under the State Legal Services Authority Regulation, 1998 read with national Legal Services Authority 9 Fee and Competent legal Services) Regulations, 2010.
4. The Panel Lawyers shall submit information about the progress of the case entrusted to him on monthly basis to the Monitoring Committee constituted for evaluation of Legal Cases.
5. The panel will be reviewed periodically in terms of the provisions laid down under Regulation 20 of the Tripura State Legal Services Authority Regulation, 1998 read with sub regulations (1) , (2) , (3) , (4) and (5) of regulation 8 of the National Legal Services Authority 1998 (Free and competent Legal Services Regulations ) 2010.
6. As directed by the State Legal Services Authority, the advocated, so empanelled are requested to render their services for legal Aid , as and when called for.
7. This is come into immediate effect.


