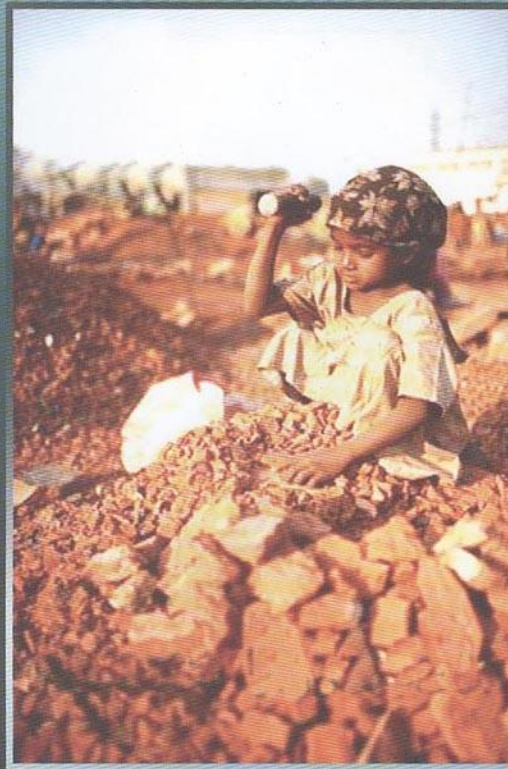


## From the Desk of the Executive Chairman

The most fundamental human right enshrined in Article 1 of the Universal Declaration Of Human Rights is that all human beings are born free and equal in dignity and rights. The Juvenile Justice (Care & Protection of Children) Act, 2000 creates a system for the protection of such rights and dignity of the Juveniles in conflict with law and child in need of care and protection and for facilitating their rehabilitation and social integration. Even an individual can render useful service to a child in need of care and protection by producing him/her before the child welfare committee. Similarly the families can come forward for adoption and foster care of orphan, abandoned or otherwise neglected or abused child. But it may be quite difficult for a person intending to help such children to extend the help unless he knows about the institutions created under this Act. This directory is designed to fill in this gap. The State Legal Services Authority has taken sincere efforts to take the benefits of the Act to the Juveniles and the children in need of care and protection. Towards these efforts, it has already conducted training programme for the Lawyers on Juvenile Justice Panel at Agartala through the West Tripura District Legal Services Authority and Organized Training of the Designated Juvenile /Child Welfare Officers of Police and the Members of Special Juvenile Police Unit in South Tripura District and North Tripura District and scheduled such programme for the West Tripura District also. But a lot more is yet to be done.

I hope that the directory will be useful to all concerned. The readers may freely give their feedback and views for its improvement in the next edition.


## About the Directory

## JUVENILE JUSTICE BOARDS \*\*

Section-4 of the Juvenile Justice (Care and protection of Children) Act, 2000 provides for constitution of one or more Juvenile Justice Boards for every district for exercising the powers and discharging the duties conferred or imposed on such boards in relation to juveniles in conflict with law under this Act. A Juvenile in conflict with law means a Juvenile who is alleged to have committed an offence and has not completed 18 years of age on the date of commission of such offence. A Juvenile in conflict with law after apprehension has to be produced within 24 hours before the Board or an individual member of the board, when the board is not sitting. At present there are 4 Juvenile Justice Boards in Tripura which are as follows.

## CHILD WELFARE COMMITTEES

Section-29 of the Juvenile Justice (Care and protection of Children) Act, 2000 provides for constitution of one or more Child Welfare Committee for every District to exercise powers and discharge the duties conferred on such committee in relation to **child in need of care and protection** under this act.

### Who is a Child in need of Care and Protection ?

According to Section 2(d) of the JJ Act, 2000 Child in need of Care and Protection means a Child,-

- (i) Who is found without any home or settled place of abode and without any ostensible means of subsistence.
  - (ia) Who is found begging or who is either a street Child or a working child.
- (ii) Who resides with a person (whether a guardian of the child or not) and such person –
  - (a) has threatened to kill or injure the child and there is a reasonable likelihood of the threat being carried out, or
  - (b) has killed, abused or neglected some other child or children and there is a reasonable likelihood of the child in question being killed, abused or neglected by that person,
- (iii) Who is mentally or physically challenged or ill children or children suffering from terminal diseases or incurable diseases having no one to support or look after.
- (iv) Who has a parent or guardian and such parent or guardian is unfit or incapacitated to exercise control over the child.

- (v) Who does not have parent or no one is willing to take care of or whose parents have abandoned or surrendered him or who is missing and run away child and whose parents can not be found after reasonable enquiry.
- (vi) Who is being or likely to be grossly abused, tortured or exploited for the purpose of sexual abuse or illegal acts,
- (vii) Who is found vulnerable and is likely to be inducted into drug abuse or trafficking.
- (viii) Who is being or likely to be abused for unconscionable gains,
- (ix) Who is victim of any arm conflict, civil commotion or natural calamity.

Who can produce a Child in need of care and protection before a child welfare committee?

Any police officer, the special Juvenile police unit or designated Juvenile or Child Welfare Officer of Police, any public servant, Child line (a registered Voluntary organization), any agency recognized by the State Government for this purpose, any social worker or public spirited citizen or the child himself may produce a child in need of Care and Protection before the Child Welfare Committee. (Section - 32)

## OBSERVATION HOME

Section - 8 of the Juvenile Justice (Care and protection of Children) Act, 2000 provides for setting up of Observation Homes. The State Government may establish such Observation Homes by itself or under agreement with voluntary organizations for every district or group of districts for temporary reception of Juveniles in conflict with law during the pendency of any enquiry regarding them under this Act.

## SPECIAL HOMES

Section - 9 of the Juvenile Justice (Care and protection of Children) Act, 2000 provides that the State Government may establish and maintain either by itself or under agreement with voluntary organizations, Special Homes in every district or a group of districts for reception and rehabilitation of Juveniles in conflict with law under this Act. Any other institution considered by the State Government to be fit for reception of such Juveniles may also be certified by the State Government as Special Home. The Juvenile Justice Board may send a Juvenile to Special Home for a period not exceeding three years if the board is satisfied on enquiry that the Juvenile has committed an offence.

## CHILDREN'S HOME

Section - 34 of the Juvenile Justice (Care and protection of Children) Act, 2000 provides that the State Government may establish and maintain either by itself or in association with voluntary organizations, Children's Homes in every district or a group of districts for reception of child in need of care and protection during the pendency of any enquiry and subsequently for their care, treatment, education, training, development and rehabilitation.

## SHELTER HOME

Under Section - 37 of the Juvenile Justice (Care and protection of Children) Act, 2000, the State Government may recognize reputed and capable voluntary organizations and provide assistance to them to run shelter homes or drop in centers for Juvenile or Children who need urgent support.

Any police officer, the special Juvenile police unit or designated Juvenile or Child Welfare Officer of Police, any public servant, Child line (a registered Voluntary organization), any agency recognized by the State Government for this purpose, any social worker or public spirited citizen or the child himself may produce a child in need of urgent support in such shelter home or drop in homes.

## AFTER CARE ORGANIZATIONS

The rehabilitation and social integration of a child shall begin during the stay of the child in special home or Children's home. It shall be carried out even when the Juvenile or Children leave the special home or Children home. They need after care to lead an honest, industrious and useful life. Therefore, Section-44 of the Juvenile Justice (Care and Protection of Children) Act provides for setting up after care organizations.

## THE PROBATION OFFICERS

Probation Officers play the key role under the Juvenile Justice (Care and Protection of Children) Act, 2000. They assist the JJ Boards during inquiry by preparing Social investigation report of Juveniles in conflict with law. The Probation Officers are also required to look after the re-habilitation and social integration of the Juveniles when the board releases the Juveniles under the supervision of Probation Officers. Such Probation Officers are appointed Under Section-13 of the Probation of offenders Act, 1958.

## DESIGNATED JUVENILE / CHILD WELFARE OFFICERS IN TRIPURA

Section 63 (2) of the Juvenile Justice (care and protection of Children) Act, 2000 provides that in every police station at least one officer with aptitude and appropriate training and orientation may be designated as the "Juvenile or the Child Welfare Officer" who will handle Juvenile or the Child in co-ordination with the police.

Pursuant to this provision the officer in charge of every police station has been designated as Juvenile / Child Welfare Officers in Tripura.

## Our Suggestions for improvement of the Juvenile Justice System in the State.

- Framing of State Rules in conformity with the model rules framed by the Central Government under section 68 of the JJ Act. This can be done either by amendment of The Tripura Juvenile Justice (Care & Protection of Children) rules 2002 or by framing new rules repealing the old rules.
- Creation of separate cadre of probation officers with orientation and training and appointment of women probation officers.
- Undertaking research and survey to ascertain the nature and extent of Juvenile delinquency in Tripura and reasons thereof and for identification of child in need of care and protection followed by appropriate measures for their rehabilitation and social integration.
- Giving priority on identification, rehabilitation and social integration of child in need of care and protection which is likely to reduce the number of Juveniles in conflict with law.
- Strengthening the adoption agencies in the state and awareness campaigning for adoption, foster care and sponsorship by hoardings, projection of slide in TV, docu drama in TV and Radio, street drama etc.
- Setting up of more JJ Boards, Children's home, shelter homes, special homes and observation homes.
- Regular inspection of the homes by the District Child Protection Units.
- Encouraging more number of voluntary organisations for involvement in the rehabilitation and social integration of children in need of care and protection.
- Introducing regular incentives to the adoptive parents on need basis.
- State Government may create the Juvenile Justice Fund as provided under section 61 for Welfare & Rehabilitation of Juvenile or Child under the JJ Act and encourage voluntary donations and contributions to the fund.
